The first session is scheduled for Wednesday, February 24 from 4-5:45. The program will continue through Wednesday, June 9. Registration will be on a first come, first served basis, with preference given to Spanish and English language studies. Participating students who are not currently enrolled in a club or tutoring session on Wednesdays may attend the ICS After-Care Program following dismissal until the start of the language session.
